- are cashed at their face value commission-free:
- are valid without time limit;
- are refunded by the Bank for Foreign Trade of the USSR in case of their loss.




Travellers Cheques of the Bank for Foreign Trade of the USSR in Roubles with free conversion are issued in denominations of 5, 10, 20 and 50 Roubles and are marked with serials "A", "B", "C" and "D" respectively.


They are sold and encashed by the biggest Banks practically throughout the world.

When selling Travellers Cheques in Roubles with free conversion, foreign Banks charge commission from their clients in ac-

cordance with their List of Terms and Conditions keeping the whole amount of commission at their disposal.

The sale and encashment of Rouble Travellers Cheques with free conversion are effected at the official rate of the State Bank of the USSR, governing on the day of operation. This rate is reported by Reuter Agency as and when it is modified and is distributed by the Bank for Foreign Trade of the USSR.





ENCASHMENT OF THE CHEQUES

The holder of the Rouble Travellers Cheques with free conversion is required to countersign the Cheque in its left upper corner in the place marked "Countersignature" in the presence of your Bank's clerk. Should the first and the second signatures not be identical or if your Bank's clerk has not witnessed the countersigning of the Cheque, please request the client to sign the Cheque once more on the reverse side. This last signature must be identical to the

sample of the client's signature on the Cheque.

The Bank for Foreign Trade of the USSR guarantees to your Bank reimbursement of the amount of the encashed Cheques provided that the signature and the countersignature of the client are identical.

When effecting encashment of Rouble Travellers Cheques of the Bank for Foreign Trade of the USSR please pay attention to the requisites given on page 7.

The refund of lost or stolen Rouble Travellers Cheques with free conversion is effected by the Bank for Foreign Trade of the USSR, Moscow. For this purpose please forward to us the refund application filled in by your client. In this application the client should indicate the date and place of purchase, the sum and denomination of the

Cheques, their numbers and whether the Cheques were signed and countersigned. To obtain our Rouble Travellers Cheques in blank, Sale Advices, Rules of their sale payment, advertisement labels, envelopes and refund applications, please fill in and mail to us a requisition form the sample of which is shown on page 12.
